Eli Bin took the Prime Minister for a tour of the complex and gave him detailed explanations of the organization's unique approach in vaccinating as efficiently as possible. The Prime Minister got an inside look at MDA's special vaccination trailer which increases accessibility to the vaccine and contributes greatly to the efficiency of MDA's efforts. In addition, Eli Bin thanked the Prime Minister for the great trust that MDA receives from the government.

According to Health Minister Yuli Edelstein, as of March 1, Israel had already administered the first vaccine dose to over 50 percent of its population, while

more than 35 percent had already received both doses. In other words, out of a population of 9.3 million, more than 4.5 million have received the first dose and over 3.25 million have received both. Prime Minister Benjamin Netanyahu aims to vaccinate all Israelis over the age of 16 by the end of March. He argues that this will allow for a post-pandemic reopening of the country in April.

"We must make the extra effort to vaccinate the 50+ age group first, but also the young people. We are about to defeat the pandemic but we are still in competition with the virus and the mutation. We will be the first country in the world to come out of corona. An additional effort, and we will come out of it together and come back to life. Go get vaccinated!" – Prime Minister Benjamin Netanyahu

Rolling her eyes, she answered "Sure!...Believe that if you want!"

With that, Tova, my wife of 40 years, left the room snickering.

Well...that wasn't polite.

I had just told her that Hershel Recht from Canadian Magen David Adom had called to ask if I would write a short article for an upcoming newsletter. We had just contributed another ambulance to CMDA. I then simply wondered if I was being asked because I might have actually become "popular" at 63?

Of course not.

Hershel is a pro and he realizes that one of the best ways to get people to give is to get those who DO give, to tell others their reasons.

I was raised in a modest bungalow in the Bathurst Manor section of Toronto, with my twin brother, Gerald, by our parents, Leslie and Gabriella Hartman. My 105-year-old mother still lives in that house and continues to give. They were Holocaust survivors who had lost almost everything. What they imprinted upon us was a love of Judaism and their desire to assist their fellow Jews. There were no fancy houses, cottages, or luxury cars in our lives. That didn't matter. When they could scrape together the necessary funds, they bought and donated a Torah to the local shul, to honour those who had been lost. Later, they saved up and purchased an ambulance for Magen David Adom.

Tova's parents, Nachum and Lea Shore, served in the Israeli War of Independence. They came to Canada, via the USA, and shared my parents' belief in the importance of helping our Jewish brethren. My dad had great fondness and respect for Tova's father, Nachum....despite his being Polish and not Hungarian.

Tova and I donated an ambulance years ago because we wanted to do something worthwhile to assist our fellow Jews in Israel. This time, I had pledged to myself (a neder in Hebrew) that if all three of my sons finished med school and their residencies, I would contribute another ambulance to CMDA.

Fortunately, in addition to an interest in medicine, my sons, Jason, Mike and Brian, also inherited a love of giving and of Israel. My son Mike is now continuing this legacy with his daughters, Lesley and Danielle.

Why CMDA? Since 1930, MDA has grown to become Israel's national emergency medical, disaster, ambulance and blood bank service. It is staffed by more than 10,000 people, mostly volunteers. They are the figurative life's blood of Israel and world renowned in the area of first-aid training.

Aren't other organizations worthwhile? Sure they are...I won't be hoodwinked into believing that any one of heart, liver, kidney, lung, etc., is more important than the others. Therefore, I go with the organization or cause that I feel is vital and well-run. My friends in Israel, who are well-connected politically and medically, encourage their own family members to volunteer and associate with MDA. I can't think of a better testimonial than that.

Why give? This is the most important question. The most basic answer is because they desperately deserve and need our assistance. As a physician, I know that the difference between life and death is often timely, state-of-the-art medical care.

If simply wanting "to do the right thing" isn't enough, let me give you another reason to donate...Do it for yourself! 40 years ago, my father-in-law told me that a major reason he gave was that it made him feel good. He was right. Material possessions can be fun to acquire and possess. The satisfaction that having "things" can give is, however, often fleeting and empty of substance. Giving to others, on the other hand, can give you extraordinary satisfaction. It can give you peace and balance that no material possession can duplicate. Giving can be an important stabilizer, akin to effective therapy. For those of you who have a religious background, you know that human kindness and giving elevate you and truly represent behaving "in G-d's image".

For a more scholarly discourse on the psychology, philosophy and halacha involved in giving, feel free to speak to my brother, Gerald. In addition to a lively discussion, he may additionally grace you with a glass of fine Scotch. Otherwise, try your therapist, Rabbi, Rebbetzin, friend, or Labradoodle.

Why give again? That's easy. Who doesn't want to repeat a pleasant and fulfilling experience? If we could have a life-altering pleasure only once in a lifetime, then there would be lots of delicious pizza left uneaten in the world.

In summary, give and keep giving to CMDA. Give because Magen David Adom needs it and will make great use of your gift. Give because ultimately you may be the one who benefits most from your giving.

CMDA EXCLUSIVE WEBINAR SERIES

The Effect of the Vaccine & Immunity What it Takes to Beat COVID-19

In February, CMDA launched a new Exclusive Webinar Series to keep Canadians informed on the amazing work Magen David Adom is doing to combat the pandemic.

The first webinar was held on February 2 and addressed the question so many people are asking: How effective is the COVID-19 vaccine on immunity? The event

featured Professor Nadav Davidovitch, an epidemiologist and Director of the School of Public Health at Ben Gurion University, as well as Yonatan (Yoni) Yagodovsky, Director of International Relations at Magen David Adom. Moderating the webinar was Dr. Stanley Herman, a physician with the International Unit of Magen David Adom.

Professor Davidovitch acknowledged MDA's efforts in mitigating the spread of the virus through its "Covid Ambassadors", a group of citizens who educate individuals in their community about safety measures related to the coronavirus. In response to a question about immunizing children under 12, the professor explained that at the present time, vaccinations are only being given to those aged 16 and up. Pregnant women are being vaccinated, as are those who have previously had the virus. Yoni Yagodovsky stressed



that MDA, in addition to playing a major role in trying to control the spread of the virus, must still deal with emergencies on a daily basis. the pandemic and how the Israeli government, the Health Ministry, and Magen David Adom have all worked together to tackle them. She outlined

Israel is a leader and at the forefront of the vaccination cam paign and, w ith help, w e w ill defeat the coronavirus and return to our daily lives.

On March 3, CMDA held a second webinar that focused on Israel's innovative approach to tackling the virus. The event featured Professor llana Belmaker, Associate Professor of Public Health at Ben Gurion University of the Negev and former Chief Physician for Israel's Health Ministry, Southern District. As well, the event featured Uri Shacham, Chief of Staff and Director of the **COVID-19 Vaccination Program** at Magen David Adom.

Professor Belmaker spoke in detail of the unique challenges that Israel faces in dealing with

important differences between Canada and Israel and how there are major factors in acquiring vaccines and immunizing the population.

Uri Shacham explained that the focus on the human element must be considered when carrying out such a large-scale operation. "There is a lot of news circulating regarding the vaccine and many people have fears. By properly educating staff and volunteers, MDA has been able to vaccinate many Israelis in a short time." According to Uri, the key is to understand the people first and then come up with solutions that address the issues directly. The vaccines are given at least 21 days apart, depending on the brand. Once an individual has received the second vaccination, he/she is considered to be fully immune and is given a green passport for six months. At the present, it is not known how long immunity will last.

Eli Bin, MDA Director General "We have taken a said, significant step in eradicating the pandemic. It is an important day when the elderly, parents, grandparents who are at high risk and a top priority in terms of vaccinations, can breathe a sigh of relief and see the light at the end of the tunnel. Israel is a leader and at the forefront of the vaccination campaign and, with help, we will defeat the coronavirus and return to our daily lives."

An Interview with Lenny Shapiro CMDA Chair, Calgary Chapter

CMDA: Thank you for your many years of support. Why did you select CMDA?

Mr. Shapiro: Magen David Adom is a remarkable organization, founded 90 years ago with the mandate to save the lives of all citizens of Israel, regardless of race, colour, or social-economic group. MDA is there for all Israelis.

CMDA: The organization relies on the work and efforts of volunteers like yourself.

Mr. Shapiro: There are dozens of Canadians doing their part for CMDA, but what is amazing is the story in Israel. Most people do not realize that MDA has more than 27,000 volunteers helping to run the organization. Without these volunteers, MDA could not function.



CMDA:While Israel has been a world leader in getting its citizens vaccinated against COVID-19, for MDA the challenge continues.

Mr. Shapiro: That's right. MDA has been on the front lines in the fight against COVID-19 from the very beginning. Of course, as first responders to most emergency medical incidents, the staff and volunteers come face-to-face with many COVID-19 patients



every day. That takes a toll on the staff, both mentally and physically.

CMDA: Why is the work of CMDA so vital?

Mr. Shapiro: Let us remember that MDA is Israel's national emergency medical service but it is funded through donations and the generosity of supporters. The money we raise in Canada is used to purchase ambulances, emergency medical scooters, and countless other pieces of essential medical equipment.

CMDA: What is the focus for you this Passover?

Mr. Shapiro: The need is always growing but this Passover we are asking people to support CMDA by contributing to the purchase of life-saving defibrillators. We know how effective these devices are at saving lives.

CMDA: What other things is CMDA doing in Western Canada?

Mr. Shapiro: We are reaching out to the community as often as we can. I am so proud of the efforts of Sharon Fraiman, CMDA Western Canada Director, and Don Sharpe, Alberta Health Services paramedic, for their dedication in presenting the "First 7 Minutes" program to community leaders and supporters in the west. While COVID-19 has slowed things down, this program has been presented to leaders in dozens of communities.

CMDA: Is there anything you would like to add?

Mr. Shapiro: On behalf of Faigel and myself, I want to wish everyone a Happy Pesach. It looks like this will be another year of virtual Seders, but things are looking better. I would also like to encourage both past and new donor to find out more about CMDA and to support our efforts in Israel.

I have been a friend and supporter of Canadian Magen David Adom for many years and have personally witnessed its amazing work saving lives in Israel when I lived there. When Hershel Recht. CMDA Central Regional Director, approached me about writing this article about donating life insurance to this vital organization, I jumped at the chance to help. And here's how you can help.

"Planned Giving," often described as leaving a legacy, is about leaving a gift for Canadian Magen David Adom in your will through a bequest, making Canadian Magen David Adom the beneficiary of highly taxed registered investments (e.g., RRSP, RRIF) or by donating a Life Insurance policy. By making a planned gift to Canadian Magen David Adom, you can help to support its important mission, fulfill your charitable goals, and create a legacy for your family.

A gift of Life Insurance can have far greater influence than you may think. For a relatively small investment today, you will have a considerable impact for Canadian Magen David Adom in the future.



There are several ways to make a gift through Life Insurance.

- 1. Purchase a new policy: You can purchase a new policy and name Canadian Magen David Adom as the owner and beneficiary. You will receive a tax receipt for premiums paid each year. Canadian Magen David Adom will receive the proceeds of the Life Insurance policy upon your death and use the funds to support its important programs. Many policies will provide an annual dividend payment to Canadian Magen David Adom while you are alive, so the Life Insurance policy can help them each year and not just at death.
- 2. Designate Canadian Magen David Adom as the beneficiary of your policy: You can name Canadian Magen David Adom as a beneficiary of a new or existing insurance policy. Upon your death, Canadian Magen David Adom will receive the proceeds of the Life Insurance, and your estate will receive a charitable tax receipt equal to the policy's death benefit. The substantial tax savings would reduce or eliminate other estate taxes owed to the CRA.
- 3. Donate an existing policy: Often individuals own Life Insurance that they purchased for financial security when they were younger. Considerations for Singles, Widows and Divorcees:

The tax department is biased against singles, widows and divorcees.

If you have a spouse and you pass away, then all of your assets roll over tax-free to the surviving spouse. Taxes would be due only upon the death of both spouses.


However, if you are single, widowed or divorced then, upon your death, your estate will pay taxes on your assets of between 27% and 54%, depending on the type of asset.

This includes registered assets (e.g., RRSP and RRIF), which are taxed at 54% (in Ontario) for any amounts over \$220,000. That means your \$1 million RRIF would reduce by \$540,000 of tax, leaving only \$460,000 to your named beneficiaries.

So what can you do?

- 1. Consider naming Canadian Magen David Adom as the beneficiary for all or part of the registered funds in your will. Now the entire amount would go to a charity you care about and none would go to the tax department.
- 2. If you don't want to change your will, get a multiple beneficiary form from your investment company and indicate a percentage or dollar amount that you would like to leave for Canadian Magen David Adom.

If you donate personally, for every \$2 you leave to Canadian Magen David Adom, you will save \$1 in tax. A corporation making the donation will save \$1 of tax for every \$1 donated.


